# *By-Laws*

## ARTICLE I

### Name

The name of the organization shall be Our Lady of the Wayside Catholic Woman's Club.

## ARTICLE II

### Purpose

This Club shall be an integral part of Our Lady of the Wayside Parish. The Pastor shall be its spiritual advisor, and all its transactions shall be subject to his approval. Its object shall be to further the spiritual, material and social interests of the parish, and to cooperate with agencies for community welfare.

## ARTICLE III

### Membership

SECTION 1—The obligations of membership are incorporated in the official Membership Pledge, which reads as follows: "As a member of the Catholic Woman's Club, I will regard it as my Christian duty: (a) to attend the Club Communion Mass regularly; (b) to attend the Club meetings regularly—to the best of my ability. I understand that: By failing in item (a) for three consecutive months, I

forfeit temporarily the title to 'Active Membership', a distinction awarded to those who faithfully observe this requirement.

"By failing in items (a) and (b) for a whole year, I forfeit title to both Regular and Social Membership and will have to present a new Membership Application for approval, if I again wish to enjoy membership privileges."

SECTION 2—Regular Membership, which involves a conforming to the By-Laws and a support of Club undertakings, is confined to registered parishioners.

Social Membership, which extends the privilege of Club service and attendance at Club meetings, is open to non-resident Catholics and to non-Catholics residing within the parish limits.

All membership is subject to the approval of the Pastor.

SECTION 3—The annual dues for Regular Members shall be three dollars, payable at the opening meeting, or one dollar and a half for the remainder of the Club year in the case of those entering after February first. Annual dues for Social Members shall be two dollars.

SECTION 4—Resignations, to become effective in the course of the Club year, must be made in writing. Failure to make the Membership Pledge or failure to fulfill it for a whole year is equivalent to resignation.

## ARTICLE IV

### Election of Officers

SECTION 1—The Officers of the Club shall be a President, First Vice-President, Second Vice-President, Secretary, and Treasurer.

SECTION 2—The President shall be elected annually; the Second Vice-President and Secretary on odd calendar years; and the First Vice-President and Treasurer on even years.

SECTION 3—No Officer shall be elected for more than two consecutive years, unless such election follows an incumbency of less than a year to fill a vacancy.

SECTION 4—Any member in good standing (i. e. who has paid her dues and made her Easter Communion) and who has been a member of the Club for one year shall be eligible for office in the Club.

SECTION 5—Nominations for Officers shall be made by a Nominating Committee of three selected by the President with the approval of the Pastor, before the April meeting. This Committee will report at the Annual Meeting. Their nominations may be supplemented from the floor. The consent of candidates must be obtained before names are used.

SECTION 6—The officers shall be elected at the Annual Meeting by ballot, and shall enter upon their terms of office at the June meeting.

## ARTICLE V

### Duties of Officers

SECTION 1—The President shall preside at all meetings of the Club. She shall select the Chairmen of the Standing Committees and shall act as ex-officio member of these Committees. She shall be Chairman of the Program and Executive Committees.

SECTION 2—The First Vice-President shall preside in the absence of the President. She shall be the Chairman of the Calendar Committee, and shall fulfill the duties of Club Editor.

SECTION 3—The Second Vice-President shall preside in the absence of the President and the First Vice-President. She shall be the Chairman of the Social Committee.

SECTION 4—The Secretary shall keep the minutes of Executive and Regular meetings of the Club; she shall conduct all correspondence of the Club; keep a correct list of all members with their addresses; order stationery; order Masses; send notices of special meetings; and forward to the Pastor announcements of meetings. She shall deliver to her successor all Club property at the June meeting.

SECTION 5—The Treasurer shall have charge of all funds belonging to the Club; shall keep an account of all receipts and disbursements in books belonging to the Club and she shall make reports in January and May of all monies received and paid out. She shall make an itemized report for the fiscal year and refer same to the



Auditing Committee at least five days before the meeting in June. All monies received by her shall be deposited by her in the name of Our Lady of the Wayside Catholic Woman's Club in the bank the Club shall select, and she shall deliver to her successor all books and property at the June meeting. Any exception to this procedure should be approved by the Executive Committee.

## ARTICLE VI Committees

SECTION 1—Each Committee Chairman shall select her Committee as soon as possible after her appointment. She shall notify the President of all Committee meetings, and it shall be her duty to consult and cooperate with members of her Committee. She shall prepare a written report for the annual meeting or upon the call of the President. No Chairman, except the First and Second Vice-Presidents, shall be appointed upon more than one Committee.

SECTION 2—The EXECUTIVE Committee shall consist of the Pastor and the Club Officers. It shall act for the Club when, in the judgment of the Pastor, such action is necessary.

SECTION 3—The ALTAR committee is privileged to perform such duties in connection with the care of the altars as the Pastor may direct.

SECTION 4—The AUDITING Committee shall consist of three members. It shall audit the accounts of the Treasurer and report at

the June Meeting or upon the call of the President.

SECTION 5—The CALENDAR Committee shall consist of the First Vice-President, Secretary, Treasurer, Chairman of the Membership Committee, and the retiring Chairman of the Membership Committee. It shall have charge of the preparation of the Club Calendars and shall distribute them at the October meeting.

SECTION 6—The CLUB EDITOR shall prepare all notices for local and city papers, including those of group activities.

SECTION 7—The HOUSE Committee shall have general charge of the place of meeting and shall arrange for the service of all refreshments to the Club.

SECTION 8—The MEMBERSHIP Committee shall solicit membership and shall supply prospective members with a Membership Pledge as set forth in Article III, Section 1.

SECTION 9—The PROGRAM Committee shall consist of the Club Officers, who shall prepare the yearly program of the Club.

SECTION 10—The RETREAT Committee shall have charge of arrangements for an annual Retreat and Day of Recollection for the women of the parish.

SECTION 11—The SCHOOL Committee shall cooperate with activities concerning the parish school.

SECTION 12—The SEWING Committee shall have charge of Club sewing and of such sewing and mending of altar linens as the Altar Committee may request.

SECTION 13—The SOCIAL Committee shall have as Chairman the Second Vice-President. The Chairman shall receive and introduce new members and make announcements of guests at Club meetings; shall have charge of the sale of tickets and shall arrange transportation for the Opening Reception and the annual Communion Breakfast when necessary.

SECTION 14—The STUDY Clubs Committee shall sponsor such study groups in the field of Catholic Action as the Club may wish to establish.

SECTION 15—The VISITING Committee shall call upon members in case of illness. In case of death of a member, or of a death in the immediate family, it shall notify members to pay their respects in a body.

SECTION 16—The WAYS AND MEANS Committee shall, on request, assist the Program Committee in bringing to successful realization the scheduled events of the yearly program.

SECTION 17—The MARSHALLS shall have charge of keeping the attendance records of the monthly Communions and meetings.

#### ARTICLE VII

##### Meetings

SECTION 1—The Annual Meeting shall be held at 1:30 p. m. the first Thursday in May.

SECTION 2—The Regular Meetings shall be held at 1:30 p. m. the first Thursday of each month, except July, August and September.

SECTION 3—Special Meetings of the Club may be called by the President or fifteen members of the Club. Notice of such meeting shall be given at a Regular Meeting or be mailed to each member at least two days before the meeting. Such notice shall contain the purpose of the meeting, and no other business shall be transacted at the meeting.

SECTION 4—Fifteen members shall constitute a quorum for all Club meetings.

#### ARTICLE VIII

##### Revision

SECTION 1—These By-Laws may be revised at any time at the request of the Pastor, by the Executive Committee, or at any Regular Meeting or any Special Meeting called for that purpose, by a two-thirds vote of the members present, and the approval of the Pastor. The Calendar Committee shall provide that the Annual Calendar embody any such revisions.

#### ARTICLE IX

##### Parliamentary Authority

SECTION 1—Robert's Rules of Order shall govern all meetings of the Club when not in conflict with the By-Laws or Standing Rules.

#### STANDING RULES

1. These Standing Rules may be created at any Club meeting

by a majority vote and shall remain in force until replaced by a majority vote.

2. To acquire active membership in Our Lady of the Wayside Catholic Woman's Club, it is necessary to sign and fulfill the provisions of the Membership Pledge.

3. GIFTS OR FLORAL OFFERINGS charged to the Club must be previously ratified by the Club or Executive Committee.

4. In the event of the death of a member the Secretary shall order a REQUIEM MASS. This privilege may be extended also to the spouse of a member.

5. There shall be an ANNUAL REQUIEM MASS for deceased members the first Thursday in November at 7:15 a. m.

6. COMMUNION SUNDAY—first Sunday of each month at 7:30 Mass.
